

MEMORANDUM OF UNDERSTANDING

BETWEEN

DAMINI (FEMICON), SURAT

This Agreement is made and entered into on Wednesday , January 11, 2023 between J.Z. SHAH ARTS & COMMERCE COLLEGE, AT & PO AMROLI- SURAT STATION, TA. CHORYASI DIST: SURAT 394107, Registered Under Society and Trust Act, and DAMINI (FEMICON) SURAT.

1.OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding between J.Z. SHAH ARTS & H.P. DESAI COMMERCE COLLEGE, AMROLI- SURAT and DAMINI (FEMICON), SURAT is:

- a. To discussed mutual goals regarding women empowerment and Social justice.
- b. To promote cultural & Social program between two Institute.
- c. To organize seminar on Women Health Awareness program.
- d. To create awareness through various games, competitions regarding women's health issues.
- e. To Promote the principles of good government and good citizenship.
- f. To Take an active interest in the civic, cultural, social, and moral welfare of the woman.

1. CONFIDENTIALITY

- a. During and for a period of Five years from the date of disclosure, each party agrees to consider as confidential all information disclosed by the other party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.
- b. The obligations above shall not extend to any confidential information for which the receiving party can prove that this information:
 - is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.
 - is already known or become known to the receiving party
 - is received from a third party having no obligations of confidentiality to the disclosing party,
 - is independently developed by the receiving party; or
 - is required to be disclosed by law or court order.

2. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be non-exclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular research agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

3. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 5 (Five) years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Research Agreement.

4. RELATIONSHIP

Nothing in this MOU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose.

5. ASSIGNMENT

It is understood by both the Parties herein that this MOU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

6. COSTS OF THE MOU

Each Party shall bear the respective costs of carrying out the obligations under this MOU.

7. SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.


